

# KNOW YOUR RIGHTS

If you have any contact with ICE or the Police:



**REMAIN SILENT:** You have the right to remain silent. Do not answer any questions. Immigration can use anything you say against you.



**STAY CALM & DO NOT RUN:** Take photos and notes, but stay calm and do not run.



**ASK TO SPEAK TO YOUR ATTORNEY & DO NOT SIGN ANYTHING:**

Do not sign forms you don't understand.  
An immigration lawyer may be able to help you fight your case.

## IF ICE COMES TO YOUR HOUSE:

- ⇒ Do not open the door. ICE can only enter if they have a warrant, they usually never do.



## IF ICE STOPS YOU IN THE STREET OR A PUBLIC PLACE:

- ⇒ Do not run. Ice will use this as an excuse to arrest you.
- ⇒ Ask if you are being arrested or detained, but do not answer their questions.—If they say you are not being arrested ask if you are free to leave.
- ⇒ Do not carry any false documents or documents from your birth country.

## IF ICE STOPS YOU WHILE DRIVING:

- ⇒ If asked, provide your drivers license, car registration and proof of insurance.
- ⇒ If you have valid immigration documents show them.
- ⇒ If not, do not answer questions about your immigration status.  
— State you are exercising your right to remain silent until you speak to your immigration attorney.



## BE PREPARED & CREATE A SAFETY PLAN IN CASE OF ARREST:

- ✓ Memorize the phone number of a friend, family member, or attorney to call if you are arrested
- ✓ Make arrangements for the care of your loved ones.
- ✓ Designate trusted friends or family members to make important decision.
- ✓ Keep copies of immigration documents, criminal records, & other important documents in a safe place accessible to a trusted friend or family member.

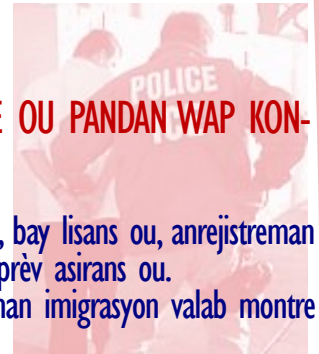
### OSWA YON LYE PIBLIK:
